The Honorable Linda S. Hallmark

Judge Linda S. Hallmark was appointed to the Oakland County Probate Court in December of 1997. Judge Hallmark serves as Chief Judge Pro Tempore of the Oakland County Probate Court. She is a member of the Circuit Court Family Division. She previously served as Chief Probate Judge from 2010-2011, and Presiding Judge of the Family Division from 2000-2004. She is a past chairperson of the State Bar Family Law Section Council, Oakland County Family Law Committee, Referees' Association of Michigan, and South East Michigan Probate Judges Association. Judge Hallmark is an appointee to the Governor's Task Force on Child Abuse and Neglect, past president of the Women Officials' Network, a fellow of the State Bar of Michigan, a fellow of the Oakland County Bar Association, Oakland Bar Inn of Court, a member of the MPJA, Women Lawyers Association, the Board of Directors of the Michigan Inter-Professional Association and the Board of the Annual Culinary Challenge.

She is a recipient of the John N. O'Brien Award, Referees Association of Michigan Service Award, Arab American Institute Service recognition, Oakland County Employee of the Year Award, the 2009 Wonder Woman Award, and the 2012 Women's Bar Association Jurist of the Year Award.

Judge Hallmark has been a presenter and author for the Michigan Judicial Institute, faculty member for the New Judge's School, the Institute for Continuing Education (ICLE), the State Bar of Michigan, the Oakland County Bar Association, Women Lawyers Association, the American Bar Association, and the Governor's Task Force on Child Abuse and Neglect.

The Honorable Kenneth Tacoma

Hon. Kenneth L. Tacoma has served as Chief Judge of Probate for Wexford County since 1994, and also as Presiding Judge of the Family Division, 28th Circuit Court, since 1998. A cum laude graduate of the Indiana University School of Law - Bloomington, he is licensed to practice in Indiana, Michigan and the Federal Courts. He was engaged in the private practice of law, served as Domestic Relations Referee for the 28th Circuit Court, and served as Wexford County Prosecuting Attorney prior to assuming judicial office.

Judge Tacoma is currently the Chairperson of the Governor's Task Force on Child Abuse and Neglect, having been appointed this office in February, 2013. He is a member of the Michigan Probate Judge's Association serving on the Executive Board since 2003 and served as President of the Association from 2011-2012. He is also a member and Past President of the Top O' Michigan Judge's Association. He has been a member of the Representative Assembly of the State Bar of Michigan, and has served on the Committee on Professional and Judicial Ethics for the State Bar of Michigan. He served two terms on the Michigan Supreme Court Forms Committee (Juvenile Proceedings and Probate Forms Sections). He is a current member of the Permanency Options Workgroup, which was first organized by then-Supreme Court Justice Maura Corrigan in 2006. He has also participated in various committees and workgroups at the request of the Michigan State Court Administrative Office, the Michigan Judicial Institute and the State Bar of Michigan, including the Judicial Crossroads Task Force from 2009-2012. He has presented at training programs throughout Michigan for the Prosecuting Attorney's Association of Michigan, the Michigan Judicial Institute, the Institute of Continuing Legal Education, and the Michigan State Court Administrative Office. He is a regular faculty member at the Michigan Judicial Institute New Judges School and a member of the Academic Advisory Committee.

Bruce D. Perry, M.D., Ph.D.



Bruce D. Perry, M.D., Ph.D. Dr. Perry is the Senior Fellow of The Child Trauma Academy, a not-for-profit organization based in Houston, TX (www.ChildTrauma.org), and adjunct Professor in the Department of Psychiatry and Behavioral Sciences at the Feinberg School of Medicine at Northwestern University in Chicago. He serves as the inaugural Senior Fellow of the Berry Street Childhood Institute, an Australian based center of excellence focusing on the translation of theory into practice to improve the lives of children (www.berrystreet.org.au).

Dr. Perry is the author, with Maia Szalavitz, of *The Boy Who Was Raised As A Dog*, a bestselling book based on his work with maltreated children and *Born For Love: Why Empathy is Essential and Endangered*. Over the last thirty years, Dr. Perry has been an active teacher, clinician and researcher in children's mental health and the neurosciences holding a variety of academic positions.

Dr. Perry was on the faculty of the Departments of Pharmacology and Psychiatry at the University of Chicago School Of Medicine from 1988 to 1991. From 1992 to 2001, Dr. Perry served as the Trammell Research Professor of Child Psychiatry at Baylor College of Medicine in Houston, Texas. During this time, Dr. Perry also was Chief of Psychiatry for Texas Children's Hospital and Vice-Chairman for Research within the Department of Psychiatry. From 2001 to 2003, Dr. Perry served as the Medical Director for Provincial Programs in Children's Mental Health for the Alberta Mental Health Board. He continues to consult with the government of Alberta on children's issues and serves as a founding member of the Premier's Council of Alberta's Promise.

Dr. Perry has conducted both basic neuroscience and clinical research. His neuroscience research has examined the effects of prenatal drug exposure on brain development, the neurobiology of human neuropsychiatric disorders, the neurophysiology of traumatic life events and basic mechanisms related to the development of neurotransmitter receptors in the brain. His clinical research and practice has focused on high-risk children. This work has examined the cognitive, behavioral, emotional, social, and physiological effects of neglect and trauma in children, adolescents and adults. This work has been instrumental in describing how childhood experiences, including neglect and traumatic stress, change the biology of the brain – and, thereby, the health of the child.

His clinical research over the last ten years has been focused on integrating emerging principles of developmental neuroscience into clinical practice. This work has resulted in the development of innovative clinical practices and programs working with maltreated and traumatized children, most prominently the Neurosequential Model[©], a developmentally sensitive, neurobiology-informed approach to clinical work (NMT), education (NME) and caregiving (NMC). This approach to clinical problem solving has been integrated into the programs at dozens of large public and non-profit organizations serving at-risk children and their families.

His experience as a clinician and a researcher with traumatized children has led many community and governmental agencies to consult Dr. Perry following high-profile incidents involving traumatized children such as the Branch Davidian siege in Waco (1993), the Oklahoma City

bombing (1995), the Columbine school shootings (1999), the September 11th terrorist attacks (2001), Hurricane Katrina (2005), the FLDS polygamist sect (2008), the earthquake in Haiti (2010) and the tsunami in Tohoku Japan (2011).

Dr. Perry is the author of over 400 journal articles, book chapters and scientific proceedings and is the recipient of numerous professional awards and honors, including the T. Berry Brazelton Infant Mental Health Advocacy Award, the Award for Leadership in Public Child Welfare and the Alberta Centennial Medal.

He has presented about child maltreatment, children's mental health, neurodevelopment and youth violence in a variety of venues including policy-making bodies such as the White House Summit on Violence, the California Assembly and U.S. House Committee on Education. Dr. Perry has been featured in a wide range of media including National Public Radio, The Today Show, Good Morning America, Nightline, CNN, MSNBC, NBC, ABC and CBS News and the Oprah Winfrey Show. His work has been featured in documentaries produced by Dateline NBC, 20/20, the BBC, Nightline, CBC, PBS, as well as dozen international documentaries. Many print media have highlighted the clinical and research activities of Dr. Perry including a Pulitzer-prize winning series in the Chicago Tribune, US News and World Report, Time, Newsweek, Forbes ASAP, Washington Post, the New York Times and Rolling Stone.

Dr. Perry, a native of Bismarck, North Dakota, was an undergraduate at Stanford University and Amherst College. He attended medical and graduate school at Northwestern University, receiving both M.D. and Ph.D. degrees. Dr. Perry completed a residency in general psychiatry at Yale University School of Medicine and a fellowship in Child and Adolescent Psychiatry at The University of Chicago.

Steve Yager

Mr. Yager graduated from Cedarville University with a B.A. in Psychology. He is currently Deputy Director of the Children's Services Administration at the Michigan Department of Human Services. He has more than 27 years of child welfare experience within the department, beginning as a children's protective services investigator and later serving as a children's services program manager, Director of the Office of Family Advocate, County Director and Child Welfare Field Director.

Mr. Yager is a strong advocate for the well-being and protection of children and has demonstrated a commitment to working collaboratively with community partners and other child welfare stakeholders.

Dr. Jeanette M. Scheid, M.D.

Dr. Scheid is an Associate Professor of Psychiatry at Michigan State University and a board certified general and child and adolescent psychiatrist. She has been in practice in Michigan for the past twelve years, where she has worked with youth and families in Community Mental Health and residential treatment settings. She has a long-standing interest in the issues faced by children and youth who have been exposed to trauma. In February 2012, Dr. Scheid joined the Michigan Department of Human Services as Medical Consultant. In this role she works with DHS and with community partners to improve the health and well-being of youth served by DHS.

Dr. Debra Luria, Ph.D. APRN, BC

Debra Luria, PhD, APRN, BC, received her BS in nursing from Michigan State University. Following that, she earned an MSN in Advanced Acute Care Nursing, MA in Marriage and Family Psychology, and PhD in Clinical and Behavioral Psychology from Wayne State University. During her doctoral studies, she minored in biopsychology and statistics. She also received a post-masters certificate in Psychiatric-Mental Health Nursing from the University of Michigan, as post-doctoral study. Dr. Luria spent the initial 16 years of her career working in medical, surgical, and cardiac critical care units, as well as brief stints in oncology, general medical-surgical, and renal transplantation milieu. She also has taught nursing and research methodology in both the undergraduate nursing and graduate nurse anesthesia programs as an assistant professor at Mercy College of Detroit, which later merged with University of Detroit to become University of Detroit Mercy. More recently, she has taught psychology in the graduate school at Madonna University. Dr. Luria is currently a fully licensed psychologist, as well as a board certified nurse practitioner.

Dr. Luria's focus of doctoral study was on health psychology, hence she has been very active in work with the Rose Cancer Center at William Beaumont Hospital, specifically through their Caring and Sharing program which offers support to women with breast cancer. She also currently maintains a general psychology practice, where she conducts psychotherapy, psychoeducational testing, as well as medication prescription. She has lectured frequently regarding proper prescription of medication for various psychiatric disorders, as well as a variety of topics which have focused largely on coping with cancer. The recipient of several awards for her work in nursing and higher education, she is always appreciative of the opportunity to participate in the lives of others at those times when they are most vulnerable.

Dr. Luria's alter-ego lies in the arts, where she enjoys chorale and performance singing, taking part in musical theatre, creating art, and taking in theatre and dance. She and her husband are ardent jitter-buggers as well. She prides herself on integrating this creative spirit into her work as a psychologist and nurse practitioner, as this makes her able to treatment plan with creativity and individuality.
